## **Description of Changes**

TE Connectivity is changing the sourcing and grade for PVDF resin used as insulation material for Spec 44 and FLDW Wires. This change is to an alternate grade with similar performance and characteristics.

## Reason for Changes:

Part status change. The technical assessment on alternate PVDF grade has been completed by TE s technical team and the results demonstrate similar properties and performance to the existing PVDF grades. These results are obtained through validation trials of various finished parts using the alternate grade as insulation material. No change to form, fit and function of the finished parts has been observed. Test reports on the wire characteristics can be provided upon request.
