Product Improvement. The material manufacturer has discontinued the red color material. The original material was naturally red in color due to the flame retardant used in								
the raw material. The new material uses a different flame re	etardant that is not naturally red in color. This change in flame retardant is the reason for the color change from red							
to black.
